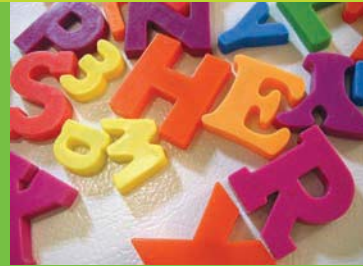


About Us
